### OUTLET OVERLOAD!

Every year, U.S. fire departments respond to an estimated 25,900 home electrical fires. These fires cause an estimated 280 deaths, 1,125 injuries and \$1.1 billion in property loss.

Thirty-nine percent of home electrical fires involve outlets and receptacles, and other electrical wiring.

To ensure safety, you should only use about 80 percent of the available current for each electrical outlet in your home.

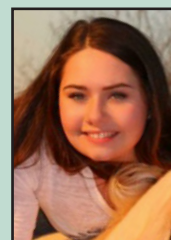

## Board of Directors Qualifications

No person shall be eligible to become or remain a director or to hold any position of trust in the cooperative who:

(B) is in any way employed by or financially interested in a competing enterprise or business selling electric energy supplies to the cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the cooperative; or

(C) Has been an employee of the cooperative within the last three (3) years.

Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the board of directors.

## Area students prepare for the 'trip of a lifetime'

HIGGINSVILLE, Mo. – Three area high school students are preparing to pack their bags for a week in Washington, D.C. Hanna Stillwell of Warresburg High School, Caitlyn Aversman of Santa Fe High School and Elizabeth Fahrmeier of Wellington-Napoleon High School were named winners of the annual Rural Electric Youth Tour competition sponsored by West Central Electric Cooperative, Inc. They will receive an all-expense-paid trip to the nation's capital June 10-16 for the National Rural Electric Youth Tour.

Finalists in the 2017 competition delivered their essays during the oral competition at West Central Electric Cooperative's headquarters in Higginsville April 6. The top three were named winners.

West Central's delegates, their teachers and families will be invited to participate in Family Capital Day June 9 in Jefferson City where they will receive a private tour of the State Capitol Building, the Missouri State Archives, and the Supreme Court. Following a banquet and orientation in Jefferson City that evening, Missouri's 100-plus-member delegation will travel to Washington, D.C. on June 10. While there, delegates will visit, among other places, the Washington Monument, and the Jefferson, Lincoln, Roosevelt, Vietnam Wall and Korean War memorials. They will get the opportunity to witness the Changing of the Guard Ceremony at the Tomb of the Unknown Soldier in Arlington National Cemetery, take an evening dance cruise on the Potomac River, and tour the Smithsonian Museums.

Also on the agenda is Youth Day which is attended by more than 1,500 delegates from 44 states, and a day on Capitol Hill where students can meet with their senators and representatives.

## Delegates get psyched for CYCLE

Local students Alice Evans of Holden High School, Zach Toole of Chilhowee High School, Brenna Schmidli of Crest Ridge High School and Jessica Paxton of Warresburg High School, will represent WCE at the Cooperative Youth Conference and Leadership Experience (CYCLE) July 12-14 in Jefferson City.

CYCLE, which is coordinated by the Association of Missouri Electric Cooperatives, has been recognized as the top cooperative youth conference in the nation. During the conference, students will spend a day at the Missouri State Capitol Building, learn about cooperatives, participate in leadership and team-building activities, and hear top-notch speakers.

Participants will also have the chance to write their own bill and debate that bill on the floor of the Missouri House of Representatives.

Past speakers at CYCLE have included Darrell Scott, whose daughter, Rachel, was killed in the shootings at Columbine High School in 1999 and Grant Baldwin and Mike Schlappi, wheelchair basketball world champion and paralympic medalist whose message is "If you can't stand up -- stand out." Students will also have the opportunity to write and debate their own bills on the floor of the Missouri House of Representatives.

Are you overloading outlets? Use this formula to find out:

wattage/volts=amps

Example:

Let's say you are using 2,000 watts of power (for one outlet). Divide the watts by the volts in your home (typically 120), and you come up with 16.6 amps of current being used. With a 20 amp electrical outlet, you are using about 80 percent of the available current.

### DON'T TOY WITH YOUR SAFETY!

When you are playing outdoors, keep a safe distance from power lines, substations and other equipment your electric co-op uses to send electricity to your home.

Flying remote controlled toys are a great way to have fun, but accidentally making contact with a power line or other electrical equipment can be dangerous and in some cases, even deadly.

- Never fly kites, or remote controlled toys near power lines.
- Stay away from power lines, meters, transformers and electrical boxes.
- Never climb trees near power lines.
- If you get something stuck in a power line, call your electric co-op.
- Never touch or go near a downed power line.

### STAY AWAY FROM DOWNED POWER LINES!

This is the time of year when when spring storms can topple power poles and lines. Never assume that just because the power is off in your home that the power is also off to the downed line outside your home.

Never touch a downed power line or try to move it using a stick or pole. Instead, contact your power company or emergency services.

Remember, you don't have to touch a downed line to get a shock, so don't go near it.

Being aware of the dangers of electricity will help you make it a safe spring!
