Minutes of the 2017 Annual Meeting of Members, August 4, 2017 To be approved at August 3, 2018 Annual Meeting of Members

The 78th Annual Meeting of Members of West Central Electric Cooperative, Inc. (hereinafter referred to as "Cooperative"), was held at the Multipurpose Building on the campus of the University of Central Missouri, Warrensburg, Johnson County, State of Missouri, on Friday, August 4, 2017, pursuant to the bylaws of the Cooperative and notice to membership. Registration began at 5:00 p.m. and a meal was served. Musical entertainment was provided by Ben Nuelle.

BUSINESS MEETING

The business session was called to order by Densil Allen, Jr., President of the Cooperative, at 7:00 pm. Robert Simmons, Secretary of the Cooperative, caused the minutes of the meeting to be kept. Youth Tour Representative Hannah Stillwell led the membership in the Pledge of Allegiance. A prayer of invocation was offered by Director Richard Strobel.

President Allen introduced special guests in attendance at the meeting and the Board of Directors.

The President called on Attorney Shawn Battagler to verify the presence of a quorum. Mr. Battagler reported that the quorum formula required the presence of 140 members and 692 members were registered at 6:30 p.m. It was therefore ordered that a quorum was established for the transaction of business.

Mr. Battagler presented the Agenda of the meeting. On motion made, seconded and passed, the Agenda was adopted as printed.

Secretary Simmons presented the Notice

of Meeting and Proof of Mailing. On motion made, seconded and passed, the membership resolved to waive the reading of the Notice of Meeting and Proof of Mailing. He referred attention to the Minutes of the 2016 Annual Meeting printed in the July issue of West Central Electric News with the Notice of Meeting. On motion made, seconded and passed, the membership resolved to approve the 2016 Annual Meeting minutes as printed.



Treasurer's Report. He directed attention to the financial information contained in the meeting program that was drawn from the audited records of the Cooperative. On motion made, seconded and passed, the membership resolved to approve the Treasurer's Report.

DIRECTOR ELECTION

President Allen called on Walter Hutcherson to present the report of the director Nominating Committee. Mr. Hutcherson affirmed that the committee nominated Robert Simmons and Richard Strobel from District 3; and Densil Allen, Jr. from District 5.

Mr. Battagler conducted the election of Directors. He noted that there were no nominations received by petition. Mr. Battagler noted that since there were two candidates from District 3 and a single candidate for District 5, it was appropriate to elect Mr. Simmons, Mr. Strobel, and Mr. Allen by motion. On motion made, seconded and passed, the membership resolved to elect Robert Simmons and Richard Strobel for District 3 and Densil Allen, Jr. for District 5.

Mr. Battagler introduced the Bylaw Proposition A: "Shall Article VII of the bylaws of West Central Electric Cooperative be amended to permit the discounted early retirement of capital credits to offset member debts owed to the cooperative?"

On motion made and seconded, the proposition was placed before the membership for discussion and debate.

Following debate, members were given instructions regarding voting and collection of ballots.

The members appointed as election judges were identified and called to collect and count bylaw proposition ballots. **MANAGER'S REPORT**

Manager Mike Gray presented the Manager's Report updating the membership on operations, maintenance, finances, EPA regulations, right-of-way maintenance programs, and storm outages. He also reminded the membership of the many convenient ways to conduct their business with the Cooperative.

ADJOURNMENT

Mr. Battagler asked for any unfinished or new business. There was none. Steve Moore and employees conducted the drawing and distribution of attendance prizes. On motion made, seconded and passed, the membership meeting was adjourned. **ELECTION RESULTS**

Following adjournment, Mr. Battagler returned to the podium to report the election results as follows: Robert Simmons, Richard Strobel, and Densil Allen, Jr. were each elected for a term of 3 years until their successors are elected and qualified.



Family: My wife, Holly, and I have three grown children: Tyler, Jordan and his wife Breanna, and Sydney



I serve on the West Central Electric Scholarship Committee and the John and Kathryn English Scholarship Committee.

Why did you agree to run for re -election to the board of directors? What do you feel qualifies you to serve as a director of the cooperative? My family have been West Central co-op members since service became available to us at our farm near 50 and 131 highways. I am aware of the original mission this co-op held to serve the rural population that the private utility companies found too unprofitable to serve. Co-ops are responsible to the members they serve; and not to profit outside investors. My commitment as a director is to stay true to this mission of service in order to meet the needs of all of our members.

What are your goals for your next threeyear term? Our most important goal is to work to provide quality, reliable service at affordable rates.

In your opinion, what is the biggest issue facing electric cooperatives today, and how do you plan to address that issue? Quality service and low rates are at the core of what we do. I feel optimistic about our co-op's future. The co-op model provides an excellent way to provide electricity. MAIL-IN BALLOT PROCEDURES

Members who are unable to attend the 79th annual meeting on Friday, Aug. 3, may still participate in the board of directors election by mail-in ballot.

• You must submit a request for a voting packet either by calling the office and requesting a packet to be sent to you, or by mailing in the form that was included with your June bills.

• All requested ballots will be mailed to members after July 9, 2018.

• Once you receive your voting packet, you may cast your vote and follow the instructions to send the ballots to the cooperative's attorney.

• Marked ballots <u>must arrive NO</u> <u>LATER THAN Aug. 2, 2018</u> at the cooperative attorney's office in order to have the votes included in the count.

• Members who are able to attend the meeting may still vote in person at the meeting and do not have to submit a mail-in ballot.

Following is the bylaw article which allows voting by mail-in ballot:

Article III

Meetings of Members Section 5. Voting Each member shall be entitled to only one vote upon each matter submitted to a vote at a meeting of the members. All questions shall be decided by a vote of a majority of the members voting thereon in person, or by mail-in ballot, in addition to those voting by any other lawful means established by resolution of the Board of Directors of the Cooperative at least sixty (60) days prior to the date of said meeting and specified in the notice of the meeting, except as otherwise provided by law, the Articles of Incorporation

Section 6. Proxies Voting by proxy shall not be permitted.

FAQs

Q. What is Operation Round Up?

A. Operation Round Up is a program to generate and collect donations that are used to benefit charitable organizations and the communities within the WCE service territory.

Q. How did Round Up begin?

A. The program was created by Palmetto Electric Cooperative in South Carolina in 1989. Since that time, the program has been adopted by more than 200 electric cooperatives nationwide and 18 cooperatives in Missouri.

Q. How does Round Up work?

A. Beginning September 1, 2018, the electric bills of WCE members will be rounded up to the next dollar. For example, if your bill is \$65.50, it would be rounded up to \$66.00. A bill of \$59.99 would be rounded up to \$60.00. The funds collected are placed into the WCE Round Up Foundation and 100% of the funds are donated to charitable organizations through an application process. WCE Round Up Foundation does not keep any of the money collected. On average, a member will donate \$6.00 a year.

Q. Is my donation tax deductible?

A. Yes, all donations are tax deductible.

Q. What if I don't want to participate?

A. WCE members are automatically enrolled in Operation Roundup. However, you can opt out of participation. No members will be forced to contribute. If you wish to opt out of the program, you can do so by contacting us at 1-800-491-3803 and tell us you'd rather not be enrolled. Or, you can complete the form included in your May bill and return it to us with your monthly payment.

Q. How much money could Operation Round Up collect?

A. WCE has over 12,000 members. If 50% of our membership participates in the program, Operation Roundup could potentially raise approximately \$36,000 per year. With 100% of those funds going to charitable organizations within our communities, the possibilities are endless.

GEOGRAPHIC FOCUS

Applications will be accepted from individuals or entities located geographically within the area served by the Cooperative. Organizations or individuals providing activities, programs, or benefits to people who live in the Cooperative geographic service area are eligible for funding consideration, even though the organization or individual resides outside the Cooperative geographic service area.

APPROVAL OF APPLICATIONS Quorum will exist with two-thirds of the board members in attendance. Complete applications will be approved with two-thirds majority vote.

FUNDING RESTRICTIONS

- Contributions shall not be made for the following:
- •Political, lobbying, fraternal, labor organizations.
- •Fund-raising dinners, raffles, and

other events.

•Capital fund campaigns. •National fund drives. •Advertising. Scholarship programs or individual scholarships.



•Uniforms or general sponsorships for league or traveling sports teams. ·Internal payroll expenses of an organization

From the Boardroom...

Regular meeting of the Board of Directors held April 26, 2018

The meeting, was called to order by Vice President Clark Bredehoeft. Robert Simmons, Secretary of the Cooperative, caused the minutes of the meeting to be kept. The following directors were present: Max Swisegood, Dale Jarman, Richard Strobel, Stan Rhodes, Sandra Streit and Jeremy Ahmann. Densil Allen Jr. was absent. Also present were General Manager Mike Gray and general counsel Sheri Smiley.

APPROVAL OF AGENDA

After discussion, the agenda was approved.

APPROVAL OF CONSENT AGENDA

The board approved its consent agenda consisting of the minutes of the regular meeting of March 22, 2018 expenditures for the month of March 2018; new membership applications; membership terminations and the treasurer's report.

APPROVAL OF REPORTS

The following March 2018 reports were approved: Operating Report (RUS Form 7) and Comparative Operating Statement including the Financial Statistical Report with month and budget comparisons and statistical data pertaining to operating revenue, expenses, margins, assets, liabilities, and KWH sales; Treasurer's Report and the written monthly Construction, Retirement, Maintenance and Operations Report.

SAFETY REPORT

Gray gave the safety report for the month of March.

NW REPORT

Swisegood presented the NW report for April. He discussed AECI updates, including the Dell Power Plant, the potential new load at New Madrid and the long range plan of AECI, NW outages, financials to date, economic development, and gave an update on a wind farm. He reported that the same Board of Director officers were elected following the annual meeting.

AMEC REPORT

Bredehoeft and Gray gave the AMEC Report for the April meeting which included the lineman's rodeo coming up in September, MECIP, the NRECA report, and pending legislation.

SCHOLARSHIP COMMITTEE REPORT

Jarman reported there were 40 applications and 23 scholarships of \$750.00 each given for a total of \$17,250.00. It was the Committee's recommendation to consider potentially giving more scholarships in 2018. A discussion was held regarding the English scholarship and the requirement to be an active 4-H member.

ANNUAL MEETING DISCUSSION

The Annual Meeting meal options were discussed. It was reported that the Nominating Committee meets on May 17th. June 4th is the deadline for Petitions. A drop box will be provided at the annual meeting for people to drop their ballots in if they do not wish to stay for the meeting. The Round up Foundation will have a table set up and Foundation board members will be at the table.

MANAGER'S REPORT

Gray presented his monthly Manager's Report. Items of interest included: the Missouri Directors Conference, the CFC Statewide Workshop, AECI's Annual Meeting, Audit Report the National Directors Survey and an update on prepaid accounts. He also gave an update on the Oak Grove Building and a facilities update
